RETURNABLE PACKAGING

Packaging is the property of Rea Magnet Wire. All spools, reels, and pallets are designed for re-use. These packaging items must be returned in order to control costs and provide the best possible pricing. Rea Magnet Wire reserves the right to charge for packaging items that are not returned.

SPOOL AND REELS

- Spools and reels should be handled with care at all times to prevent damage. Avoid tossing and dropping.
- Empty spools and reels should be stacked on pallets in a manner to optimize space. They should be banded or shrink-wrapped so they remain intact during transport. Please avoid using tape for securement.
- Spools and reels should be stored indoors until they are returned. If outdoor storage is necessary, they should be covered with non-transparent plastic to prevent exposure to the elements. Prolonged exposure to sunlight will weaken them.
- Unless otherwise directed, customers should return reels and spools by the appropriate method as designated below (see section entitled "How To Return Packaging").

PALLETS

- Rea Magnet Wire uses pallets that are specifically designed to hold the products produced. These pallets, regardless of construction material (wood/plastic/metal), must be returned.
- Pallets should be stacked approximately 7 to 8 feet high for return. They should be banded or shrink-wrapped so the stacks remain intact during transport.
- Stacks of pallets should be returned at the same time spools and reels are returned. They can be loaded on the same truck.
- Unless otherwise directed, customers should return pallets by the appropriate method as designated below (see section entitled "How To Return Packaging").
